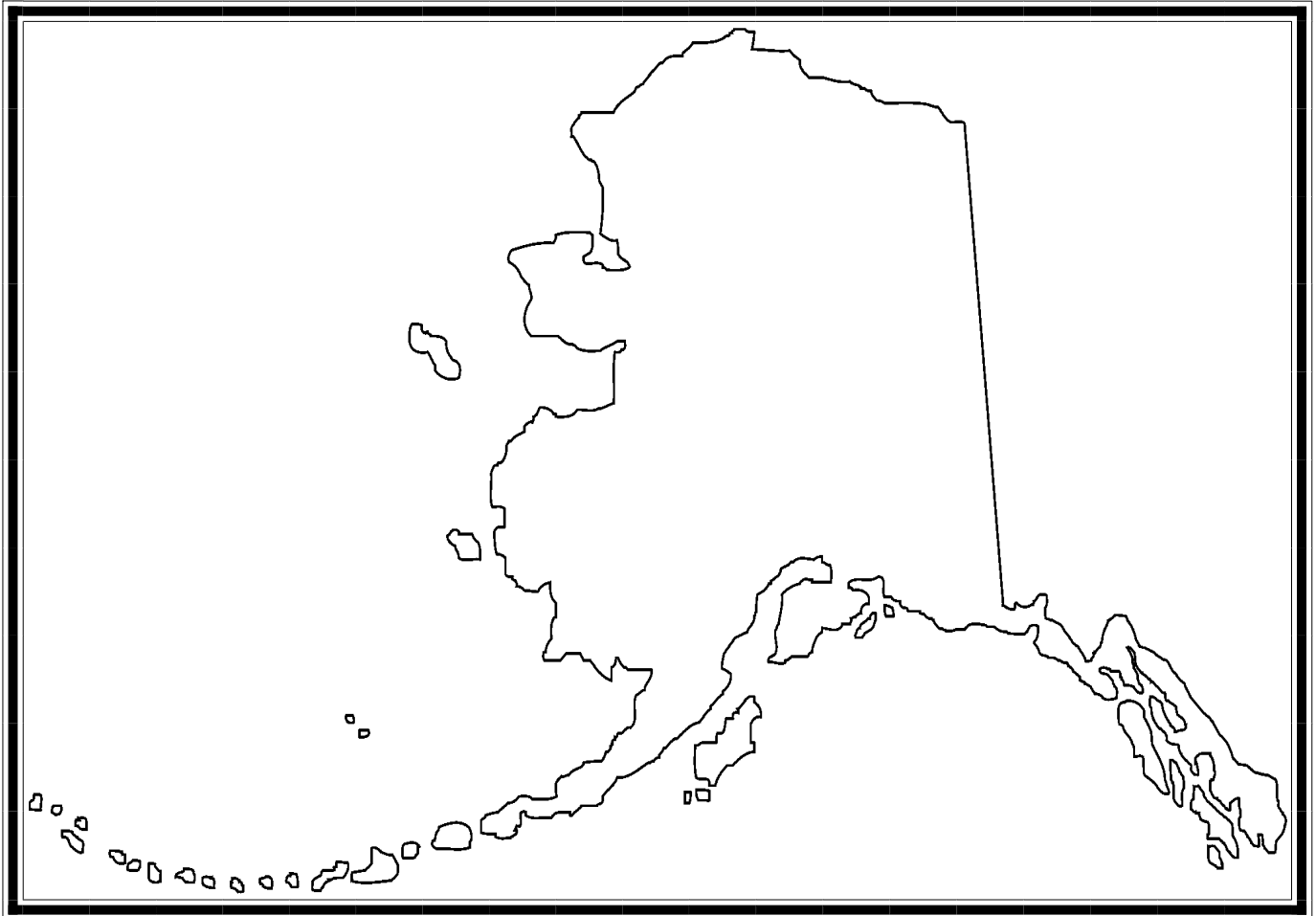

This directory is updated each year to provide a comprehensive listing of all state-chartered banks, national banks, state and federal thrifts and credit unions, small loan companies, premium finance companies, trust companies, and BIDCOS, that are approved and operating in the State of Alaska as of February 14, 2003. We hope the information is helpful, and we welcome any comments you may have.

The Division of Banking, Securities and Corporations charters, licenses, and supervises state-chartered commercial banks (3), mutual savings banks (1), credit unions (2), trust companies (2), bank holding companies (3), small loan offices (8), premium finance offices (21), and BIDCOS (1). In addition to these state-chartered institutions, there are 4 nationally-chartered commercial banks, 1 federal chartered savings bank, and 13 federal credit unions. This directory provides a listing of the 256 offices of these financial institutions.

Total assets for all banks with home offices in Alaska were \$7,181,993,000 as of December 31, 2002, an increase of \$575,995,000 or 8.72% from a year ago. This total excludes Key Bank, National Association, which does not furnish balance sheet information for Alaska.

Total assets of all state-chartered banks in Alaska were \$1,344,379,000 as of December 31, 2002, an increase of \$92,085,000, or 7.35% from a year ago. Approximately 18.72% of the total assets of all banks in Alaska were held in state-chartered institutions.

Total assets for all credit unions in Alaska were \$3,098,719,762 as of September 30, 2002, an increase of \$121,548,091 or 4.08% from December 31, 2001. Total assets for all state-chartered credit unions in Alaska were \$429,860,626 as of December 31, 2002, an increase of \$55,084,338 or 14.70% from the end of 2001. Approximately 13.87% of the total assets of all credit unions were held in state-chartered institutions.
