



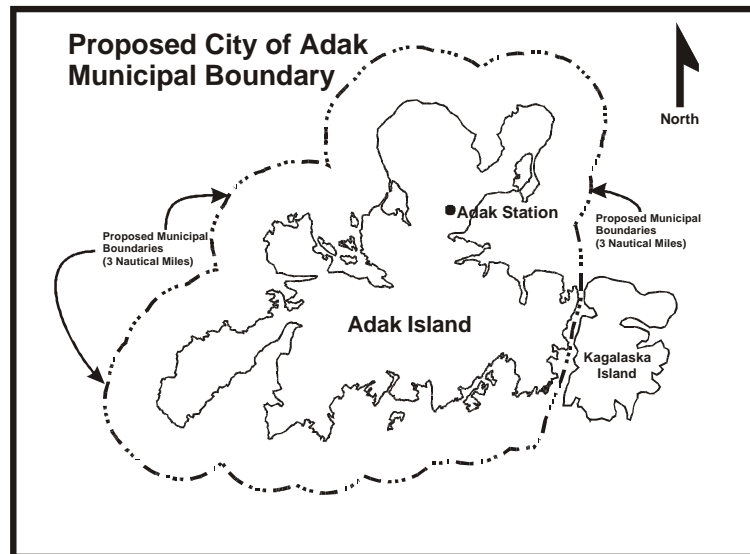
PUBLIC NOTICE

FILING OF PETITION FOR INCORPORATION OF THE CITY OF ADAK

Resident voters of Adak have petitioned to incorporate a second class city with boundaries encompassing approximately 676.3 square miles. The area proposed for incorporation is shown below.

The petition is available for public review at the Bob Reeve High School display case in Adak. The petition is also available for review at the offices of the Local Boundary Commission staff in Anchorage at the address listed below.

Any person or entity may file a responsive brief or informal written comments supporting or opposing the proposed city incorporation. Responsive briefs must be filed in accordance with 19 AAC 10.480. A person who files a responsive brief (as distinguished from informal comments) gains certain procedural rights during the incorporation proceedings. Comments must be received by Local Boundary Commission staff at the Anchorage address noted below **no later than 5:00 p.m., July 20, 1999.**
