

**SECOND SUPPLEMENTAL NOTICE OF PROPOSED  
CHANGES IN THE REGULATIONS OF THE  
LOCAL BOUNDARY COMMISSION**

This is a SECOND SUPPLEMENTAL NOTICE to the Notice of Proposed Changes in the Regulations of the Local Boundary Commission (LBC) that was issued on February 2, 2007, and the Supplemental Notice thereto issued February 16, 2007, both hereby incorporated by reference, concerning proposed regulation changes in Title 3 of the Alaska Administrative Code relating to municipal boundary changes (File No. 993-07-0095).

the facsimile phone number (1-907-269-4539) or at one of the addresses specified in the February 2, 2007 public notice.


