Use form AKMA5 to register as an Alaska Small Mortgage Lender under the Alaska Mortgage Lender Regulation Act. Along with the form AKMA5, send the following information to the Division of Banking and Securities. See AS 06.60.017.

1. FEE -- Make your check payable to the "State of Alaska". Clip it (no staples) to the top of the application package.
 - a. Small Mortgage Lender Registration fee: \$150.
 - b. First Biennial License Fee: \$150 due thirty (30) days before the expiration of any registration.
2. REGISTERED AGENT – (a) If your company is created or registered in the State of Alaska, please provide a copy of your most recent filing where a registered agent has been appointed. (b) If your company is not registered in the State of Alaska, you may need to comply with the registration requirements under Title 10 of the Alaska Statutes.

3. SMALL MORTGAGE LENDER ORIGINATOR – On your letterhead, tell us who will be (if applicable) your SMALL MORTGAGE LENDER ORIGINATOR (SMLO).

INSTRUCTIONS

A. GENERAL INSTRUCTIONS

1. **FILING** – Form AKMA5 is the Alaska small mortgage lender registration application. Any *applicant* to be registered as a small mortgage lender must submit this application to the Division of Corporation, Business and Professional Licensing.
2. **TERMS USED** – See the following Explanation of Terms section regarding italicized words/phrases.
3. **EXECUTION** – The execution section must be completed by an authorized representative of the applicant.
4. **DATES** – The filing date is the date *applicant* submits this form to the State of Alaska.
5. **AMENDMENTS** – The *applicant* must update information as required in AS 06.60.017(f)(3) at the time of any registration renewal by submitting amendments using Form AKMA5. Circle (or otherwise identify) and complete the item(s) being amended as well as the name of the *applicant*.
6. **CONTACT EMPLOYEE** – The individual listed as the contact employee must be authorized to receive all compliance and registration information, communications, mailings, and be responsible for disseminating it within the *applicant's* organization.
7. **SURRENDER / CANCEL**– When an *applicant* decides to cease operations under the registration, use the Form AKMA5 to notify the State of Alaska by checking “Surrender/Cancel”. Send the original registration document to the Division of Banking and Securities. Review published requirements concerning additional specific requirements at surrender/cancellation.

B. FILING INSTRUCTIONS

1. FORMAT

- A. Submit a fully completed Form AKMA5 when the *applicant* is filing for registration as a small mortgage lender the first time or when renewing a registration as a small mortgage lender.
- B. When filing Form AKMA5, the Execution section must include notarized original manual signature.
- C. Type all information.
- D. Use only the current version of Form AKMA5 and its Schedules or a reproduction of them.

2. ATTACHMENTS – Provide the following:

- A. Review published Alaska -specific instructions concerning attachments in PDF or alternative formats.
- B. Provide the name, full delivery address, and telephone number of the registered agent for service of legal process. Consult the Alaska Corporations Code and other statutes and rules.
- C. Fees \$150.
- D. If the *applicant* is a corporation, enclose a copy of the Articles of Incorporation, including amendments, as well as a Certificate of Good Standing issued by the domestic state. Review published jurisdiction-specific instructions to determine requirements for a Certificate of Good Standing from the jurisdiction in which application is being made. If the *applicant* is a limited liability company (LLC), enclose a copy of the Articles of Organization and operating agreement as well as a Certificate of Good Standing issued by the domestic state. Review published jurisdiction-specific instructions to determine requirements for a Certificate of Good Standing from the jurisdiction in which application is being made.
- E. If the *applicant* is a partnership of any form, enclose a copy of the partnership agreement. If the *applicant* is a limited partnership, enclose a Certificate of Good Standing issued by the domestic state. Review published jurisdiction-specific instructions to determine requirements for a Certificate of Good Standing from the jurisdiction in which application is being made.
- F. If the *applicant* is a sole proprietorship, review published jurisdiction-specific instructions for additional requirements.
- G. Individual(s) originating or soliciting to originate small mortgage loans at the business may need to file a Form AKMA6. Review published jurisdiction-specific instructions to verify the requirements for individuals.

3. FINANCIAL RESPONSIBILITY, EXPERIENCE, CHARACTER, AND GENERAL FITNESS – Review published Alaska specific requirements in which the *applicant* is applying to determine requirements for financial responsibility, experience, character, and general fitness. See As 06.60.017(d). These may include the submission of financial statements, minimum net worth, or other documentation of the person applying for registration as well as the person’s directors, officers, members, owners, and other principals.

C. EXPLANATION OF TERMS – The following terms are italicized throughout Form AKMA5

1. GENERAL

APPLICANT – The small mortgage lender applying or amending information regarding registration on this form.

JURISDICTION – A state, the District of Columbia, the Commonwealth of Puerto Rico, or any subdivision or regulatory body thereof.

PERSON – An individual, partnership, limited partnership, corporation, trust, LLC or other legal entity or organization.

SETTLEMENT SERVICES – The same as defined in federal Real Estate Settlement Procedures Act (RESPA) 12 U.S.C. Sec. 2601 et seq., Regulation X, 24 C.F.R. Part 3500 et seq.

2. FOR THE PURPOSE OF ITEM 6

CHARGED – Being accused of a crime in a formal complaint, information, or indictment (or equivalent formal charge).

CONTROL AFFILIATE – A partnership, corporation, trust, LLC, or other organization that directly or indirectly controls, or is controlled by, the applicant.

ENJOINED – Includes being subject to a mandatory injunction, prohibitory injunction, preliminary injunction, or a temporary restraining order.

FELONY – For jurisdictions that do not differentiate between a felony and a misdemeanor, a felony is an offense punishable by a sentence of at least one year imprisonment and/or a fine of at least \$1,000. The term also includes a general court martial.

FINANCIAL SERVICES OR FINANCIAL SERVICES RELATED – Pertaining to securities, commodities, banking, insurance, consumer lending, or real estate (including, but not limited to; acting as or being associated with a bank or savings association, credit union, small mortgage lender, small mortgage lender, real estate salesperson or agent, closing agent, title company, or escrow agent).

FOUND – Includes adverse final actions, including consent decrees in which the respondent has neither admitted nor denied the findings, but does not include agreements, deficiency letters, examination reports, memoranda of understanding, letters of caution, admonishments, and similar informal resolutions of matters.

INVOLVED – Doing an act or omission or aiding, abetting, counseling, commanding, inducing, conspiring with or failing to reasonably supervise another in doing an act or omission.

MISDEMEANOR – For jurisdictions that do not differentiate between a felony and a misdemeanor, a misdemeanor is an offense punishable by a sentence of less than one year imprisonment and/or a fine of less than \$1,000. The term also includes a special court martial.

ORDER – A written directive issued pursuant to statutory authority and procedures, including orders of denial, suspension, or revocation; does not include special stipulations, undertakings or agreements relating to payments, limitations on activity or other restrictions unless they are included in an order.

PROCEEDING – Includes a formal administrative or civil action initiated by a governmental agency, self-regulatory organization or a foreign financial regulatory authority; a felony criminal indictment or information (or equivalent formal charge); or a misdemeanor criminal information (or equivalent formal charge). The term does not include other civil litigation, investigations, or arrests or similar charges affected in the absence of a formal criminal indictment or information (or equivalent formal charge).
