## ELECTRICAL ADMINISTRATOR LICENSE APPLICATION

In accordance with AS 08.40.090 (a), a person may not act as an electrical administrator in the state without a license issued by the Department; (b) a person licensed under this chapter may perform work only in a category for which the person is licensed.

Please read the application, statutes, regulations, and all instructions carefully. It is your responsibility to be aware of licensing requirements and provide all necessary documentation.

An electrical administrator may be licensed in the following categories:

- Unlimited Commercial Wiring (UCW)
- Residential Wiring (RW)
- Controls and Control Wiring (CNTL)
- Inside Communications (IC)
- Outside Communications (OC)
- Unlimited Line Work Outside (UL)

### LICENSURE BY EXAMINATION

The following documents must be submitted to this office before an applicant will be considered for licensure by examination:

1. Completed, notarized application.
2. Fees:
  - \$ 50.00 Nonrefundable application fee
  - \$200.00 License fee
3. Complete resume detailing education and experience in the license category for which you are applying.
4. "Certificate in Support of Applicant's Experience and Qualifications" from three persons who are licensed in the electrical industry in any state in the category of electrical administrator for which you are applying (or if applying for inside or outside communications, from three persons employed in the electrical industry in any state in the license category for which you are applying). Individuals completing the form must have personal knowledge of your work experience and qualifications.
5. Official transcripts from a college, university, or trade school sent directly to the Division of Corporations, Business and Professional Licensing by the school (if using education to qualify).
6. Electrical Administrator exam results showing successful passage in the category for which you are applying (examination results are valid for one year from the date of the examination).

To register for the examination, contact Prometric (testing agency) at: [www.prometric.com](http://www.prometric.com) or call Prometric Candidate Call Center at 1-800-280-3926. Exam Registration Forms are available from Prometric. The Registration form and exam fee must be received by Prometric on or before the deadline date (30 days before the examination date.) If the Registration form is received after the deadline, the candidate will be scheduled for the next available date at that site.

An applicant may not test for more than two electrical administrator license categories at any one scheduled exam. Once licensed, additional categories may be added to the existing license by qualifying and submitting the \$50.00 application fee and passing the exam.

### LICENSURE BY CREDENTIALS

Please be advised that passing an exam in another state does not necessarily qualify an applicant for an Alaska license. Additionally, all other requirements under statute and regulation must be met. The following documents must be submitted to this office before an applicant will be considered for licensure by credentials:

1. Completed, notarized application.
2. Fees:
  - \$ 50.00 nonrefundable application fee
  - \$200.00 license fee
3. Complete resume detailing education and experience in the license category for which you are applying.
4. "Certificate in Support of Applicant's Experience and Qualifications" from three persons who are licensed in the electrical industry in any state in the category of electrical administrator for which you are applying (or if applying for inside or outside communications, from three persons employed in the electrical industry in any state in the license category for which you are applying). Individuals completing the form must have personal knowledge of your work experience and qualifications.
5. Official transcripts from a college, university, or trade school sent directly to the Division of Corporations, Business and Professional Licensing by the school (if using education to qualify).
6. Verification of a current, active license from another state, sent directly to the division by that state, that identifies any relevant license category.
7. Verification of an examination passed in another state, sent directly to the division by that state, that is equivalent to the examination administered in this state. The verification must include the examination content outline. To determine exam equivalency, please review the Alaska Electrical Administrator Candidate Registration Bulletin at: <http://www.Prometric.com/Alaska/Construction.htm>.

## **ASSIGNMENT INFORMATION**

An electrical administrator must be assigned to a licensed/registered contractor. Note that assignment is limited to one licensed contractor. A licensee not practicing as an electrical administrator may be issued a license in an “unassigned” status.

**Sec. 08.40.130. Administrator limited to one registered contractor.** A person may not qualify for or operate as an electrical administrator for more than one registered contractor.

**Change of employer or company affiliation.** A licensed electrical administrator shall notify the department in writing within 15 days after a change in electrical administration employment or company affiliation by submitting the Change of Employer/Affiliation form and \$5.00.

**PAYMENT OF CHILD SUPPORT** – Alaska Statute 25.27.244 requires the Division of Corporations, Business and Professional Licensing to deny issuance of the professional and occupational licenses of any person reported by the Alaska Child Support Services Division (CSSD) as not in substantial compliance with a child support order. If this office is notified by the CSSD that you are not in substantial compliance with a child support order, you may be issued a nonrenewable, temporary license valid for 150 days. # Electrical Administrator License Categories, Qualifications and Scope

## UNLIMITED LINework CATEGORY

**12 AAC 32.055. QUALIFICATIONS FOR AN ELECTRICAL ADMINISTRATOR LICENSE IN THE UNLIMITED LINework CATEGORY.** An applicant for an electrical administrator license in the unlimited linework category shall furnish proof satisfactory to the department that the applicant has

- (1) practical experience as a journeyman lineman in outside linework for at least four of the six years immediately before the date of application;
- (2) construction management experience in outside linework as a field superintendent or similar position in outside linework for at least four of the six years immediately before the date of application;
- (3) a degree in electrical engineering from a nationally or regionally accredited college or university plus practical experience as a journeyman lineman or field engineer in outside linework for at least one of the three years immediately before the date of application;
- (4) a registration in the state as a professional electrical engineer plus management experience in the electrical construction industry as a field engineer or in a similar engineering position for at least one of the three years immediately before the date of application; or
- (5) experience as a journeyman lineman in outside linework for three of the six years immediately before the date of application and
  - (A) one year of experience during those six years as a certified electrical inspector for a state or municipality;
  - (B) one year of experience during those six years as a full-time electrical instructor at a college, university, or trade school that is nationally or regionally accredited or approved by the Alaska Commission on Postsecondary Education; or
  - (C) completion of a curriculum that the division determines is related to outside linework at a college, university, or trade school that is nationally or regionally accredited or approved by the Alaska Commission on Postsecondary Education.

**12 AAC 32.065. EXAMINATION FOR AN ELECTRICAL ADMINISTRATOR LICENSE IN THE UNLIMITED LINework CATEGORY.** An applicant for an electrical administrator license in the unlimited linework category will be examined to determine the

- (1) applicant's knowledge of outside linework and outside communications;
- (2) familiarity with the applicable portions of the regulations contained in the National Electrical Code and the National Electrical Safety Code, as approved by the American National Standards Institute, other applicable installation and safety regulations approved by the American National Standards Institute; and
- (3) practical skill and ability in outside linework and outside communications.

**12 AAC 32.075. SCOPE OF AN ELECTRICAL ADMINISTRATOR LICENSE IN THE UNLIMITED LINework CATEGORY.** (a) The holder of an electrical administrator license in the unlimited linework category may supervise, in accordance with AS 08.40.195,

- (1) all outside linework defined in (b) of this section; and
  - (2) the work defined under the outside communications category in 12 AAC 32.125(b).
- (b) Outside linework includes
- (1) all work necessary to the assembling, installation, erection, operation, maintenance, or repair of all electrical apparatus, devices, wires, cables, supports, insulators, conductors, ducts, and raceways when they are part of distribution systems outside of buildings and are outside of property lines of any given property up to and including the primary side of transformers;
  - (2) all underground ducts and cables when they are part of a system of a distributing company or utility;
  - (3) all outdoor substations and electrical connections up to and including the setting of transformers and the connecting of the primary busses to them;
  - (4) all outdoor street lighting on public thoroughfares, roadways, and rights-of-way;
  - (5) all linework consisting of wood, concrete, metal, or substitutes for those materials; and
  - (6) all linework consisting of poles or towers, including wires, cables, or other apparatus supported by them.

## OUTSIDE COMMUNICATIONS CATEGORY

**12 AAC 32.105. QUALIFICATIONS FOR AN ELECTRICAL ADMINISTRATOR LICENSE IN THE OUTSIDE COMMUNICATIONS CATEGORY.** An applicant for an electrical administrator license in the outside communications category shall furnish proof satisfactory to the department that the applicant

- (1) has practical experience as a journeyman in outside communications for at least two of the four years immediately before the date of application; or
- (2) is a graduate of a college, university, or trade school in outside communications that is nationally or regionally accredited or approved by the Alaska Commission on Postsecondary Education.

**12 AAC 32.115. EXAMINATION FOR AN ELECTRICAL ADMINISTRATOR LICENSE IN THE OUTSIDE COMMUNICATIONS CATEGORY.** An applicant for an electrical administrator license in the outside communications category will be examined to determine the

- (1) applicant's knowledge of outside communications;
- (2) familiarity with the applicable portions of the regulations contained in the National Electrical Code and the National Electrical Safety Code, as approved by the American National Standards Institute, other applicable installation and safety regulations approved by the American National Standards Institute; and
- (3) practical skill and ability in outside communications.

**12 AAC 32.125. SCOPE OF AN ELECTRICAL ADMINISTRATOR LICENSE IN THE OUTSIDE COMMUNICATIONS CATEGORY.** (a) The holder of an electrical administrator license in the outside communications category may supervise all work defined in (b) of this section in accordance with AS 08.40.195.

- (b) Outside communications includes outside linework as defined in 12 AAC 32.075(b) but limited to the installation, operation, maintenance, and repair of telephone, telegraph, cable television, and intercommunication facilities, up to the first point of distribution or the first terminal inside of building or property lines.

## UNLIMITED COMMERCIAL WIRING CATEGORY

**12 AAC 32.145. QUALIFICATIONS FOR AN ELECTRICAL ADMINISTRATOR LICENSE IN THE UNLIMITED COMMERCIAL WIRING CATEGORY.** An applicant for an electrical administrator license in the unlimited commercial wiring category shall furnish proof satisfactory to the department that the applicant has

- (1) practical experience as a journeyman electrician in inside commercial wiring for at least four of the six years immediately before the date of application;
- (2) construction management experience in inside wiring as a field superintendent or similar position in inside wiring for at least four of the six years immediately before the date of application;
- (3) a degree in electrical engineering from a nationally or regionally accredited college or university plus practical experience as a journeyman electrician or field engineer in inside commercial wiring for at least one of the three years immediately before the date of application;
- (4) a registration in the state as a professional electrical engineer plus management experience in the electrical construction industry as a field engineer or in a similar position for at least one of the three years immediately before the date of application; or
- (5) experience as a journeyman electrician in inside commercial wiring for three of the six years immediately before the date of application and
  - (A) one year of experience during those six years as a certified electrical inspector for a state or municipality;
  - (B) one year of experience during those six years as a full-time electrical instructor at a college, university, or trade school that is nationally or regionally accredited or approved by the Alaska Commission on Postsecondary Education; or
  - (C) completion of a curriculum that the division determines is related to inside commercial wiring at a college, university, or trade school that is nationally or regionally accredited or approved by the Alaska Commission on Postsecondary Education.

**12 AAC 32.155. EXAMINATION FOR AN ELECTRICAL ADMINISTRATOR LICENSE IN THE UNLIMITED COMMERCIAL WIRING CATEGORY.** An applicant for an electrical administrator license in the unlimited commercial wiring category will be examined to determine the

- (1) applicant's knowledge of commercial and residential inside wiring, inside communications, and low voltage control wiring;
- (2) familiarity with the applicable portions of the regulations contained in the National Electrical Code and other applicable installation and safety regulations approved by the American National Standards Institute; and
- (3) practical skill and ability in commercial and residential inside wiring, inside communications, and low voltage control wiring.

**12 AAC 32.165. SCOPE OF AN ELECTRICAL ADMINISTRATOR LICENSE IN THE UNLIMITED COMMERCIAL WIRING CATEGORY.** (a) The holder of an electrical administrator license in the unlimited commercial wiring category may supervise, in accordance with AS 08.40.195,

- (1) all inside wiring work defined in (b) of this section;
  - (2) the work defined under the inside communications category in 12 AAC 32.195(b);
  - (3) the work defined under the residential wiring category in 12 AAC 32.235(b); and
  - (4) the work defined under the controls and control wiring category in 12 AAC 32.275(b).
- (b) Inside wiring includes
- (1) installation, construction, operation, maintenance, and repair of all electrical work subject to the National Electrical Code within buildings and within property lines of any given property, and beginning at the secondary side of the transformer or street lighting and traffic signalization on public thoroughfares, roadways, or rights-of-way; and
  - (2) work starting immediately after the first point of attachment of aerial or underground conductors to buildings or structures if aerial or underground wires or cables are used to provide power for buildings or structures within the property lines of any given property.
- (c) Unlimited commercial wiring does not include
- (1) linework consisting of poles and towers, including the wires, cables, and other apparatus supported by them; and
  - (2) outdoor substations or other work defined under the unlimited linework category.

## INSIDE COMMUNICATIONS CATEGORY

**12 AAC 32.175. QUALIFICATIONS FOR AN ELECTRICAL ADMINISTRATOR LICENSE IN THE INSIDE COMMUNICATIONS CATEGORY.** An applicant for an electrical administrator license in the inside communications category shall furnish proof satisfactory to the department that the applicant

- (1) has practical experience as a journeyman in inside communications for at least two of the four years immediately before the date of application; or
- (2) is a graduate of a college, university, or trade school in inside communications that is nationally or regionally accredited or approved by the Alaska Commission on Postsecondary Education.

**12 AAC 32.185. EXAMINATION FOR AN ELECTRICAL ADMINISTRATOR LICENSE IN THE INSIDE COMMUNICATIONS CATEGORY.** An applicant for an electrical administrator license in the inside communications category will be examined to determine

- (1) the applicant's knowledge of inside communications;
- (2) familiarity with the applicable portions of the regulations contained in the National Electrical Code and other applicable installation and safety regulations approved by the American National Standards Institute; and
- (3) practical skill and ability in inside communications.

**12 AAC 32.195. SCOPE OF AN ELECTRICAL ADMINISTRATOR LICENSE IN THE INSIDE COMMUNICATIONS CATEGORY.** (a) The holder of an electrical administrator license in the inside communications category may supervise all work defined in (b) of this section in accordance with AS 08.40.195.

- (b) Inside communications includes work within the inside wiring jurisdiction but limited to the installation, operation, maintenance, and repair of telephone, telegraph, cable television, and intercommunication facilities, beginning at the first point of distribution or the first terminal inside of buildings or property lines.

## RESIDENTIAL WIRING CATEGORY

### **12 AAC 32.215. QUALIFICATIONS FOR AN ELECTRICAL ADMINISTRATOR LICENSE IN THE RESIDENTIAL WIRING CATEGORY.**

An applicant for an electrical administrator license in the residential wiring category shall furnish proof satisfactory to the department that the applicant has practical experience as a journeyman residential wireman for at least two of the four years immediately preceding the date of application.

**12 AAC 32.225. EXAMINATION FOR AN ELECTRICAL ADMINISTRATOR LICENSE IN THE RESIDENTIAL WIRING CATEGORY.** An applicant for an electrical administrator license in the residential wiring category will be examined to determine the

- (1) applicant's knowledge of residential wiring;
- (2) familiarity with the applicable portions of the regulations contained in the National Electrical Code and other applicable installation and safety regulations approved by the American National Standards Institute; and
- (3) practical skill and ability in residential wiring.

**12 AAC 32.235. SCOPE OF AN ELECTRICAL ADMINISTRATOR LICENSE IN THE RESIDENTIAL WIRING CATEGORY.** (a) The holder of an electrical administrator license in the residential wiring category may supervise all work defined in (b) of this section, in accordance with AS 08.40.195, on a residential dwelling unit not exceeding three stories in height and no larger than a four-plex except three phase services and wiring.

(b) Residential wiring is limited to the residential occupancies described in (a) of this section, and includes

- (1) inside wiring work as defined in 12 AAC 32.165(b);
- (2) inside communications work as defined in 12 AAC 32.195(b); and
- (3) control and control wiring work as defined in 12 AAC 32.275(b).

## CONTROLS AND CONTROL WIRING CATEGORY

**12 AAC 32.255. QUALIFICATIONS FOR AN ELECTRICAL ADMINISTRATOR LICENSE IN THE CONTROLS AND CONTROL WIRING CATEGORY.** An applicant for an electrical administrator license in the controls and control wiring category shall furnish proof satisfactory to the department that the applicant is licensed as a mechanical administrator under AS 08.40 and 12 AAC 39 and has

- (1) practical experience as a journeyman installing low voltage controls of 48 volts or less for at least two of the four years immediately before the date of application;
- (2) construction management experience in low voltage control wiring as a field superintendent or similar position in low voltage control wiring for at least two of the four years immediately before the date of application; or
- (3) a registration in the state as an electrical or mechanical engineer plus management experience in the electrical or mechanical low voltage control wiring industry as a field engineer for at least one of the three years immediately before the date of application.

**12 AAC 32.265. EXAMINATION FOR AN ELECTRICAL ADMINISTRATOR LICENSE IN THE CONTROLS AND CONTROL WIRING CATEGORY.** An applicant for an electrical administrator license in the controls and control wiring category will be examined to determine the

- (1) applicant's knowledge of low voltage control wiring;
- (2) familiarity with the applicable portions of the regulations contained in the National Electrical Code and other applicable installation and safety regulations approved by the American National Standards Institute; and
- (3) practical skill and ability in low voltage control wiring.

**12 AAC 32.275. SCOPE OF AN ELECTRICAL ADMINISTRATOR LICENSE IN THE CONTROLS AND CONTROL WIRING CATEGORY.** (a) The holder of an electrical administrator license in the controls and control wiring category may supervise all work defined in (b) of this section in accordance with AS 08.40.195.

(b) Controls and control wiring includes the installation of low voltage controls and control wiring of 48 volts or less for heating, plumbing, process piping, cooling, ventilating, humidifying, and refrigerating equipment. Nothing in this section limits the authority or responsibility of a mechanical administrator to ensure that the controls being installed or modified properly function as an integral part of the mechanical system.

(c) Controls and control wiring does not include the installation of power wiring.

**12 AAC 32.930. YEAR OF EXPERIENCE DEFINED.** In this chapter, a year of experience means that within a 12-consecutive-month period the applicant worked in a required field or position for at least 1,500 hours.
